HEALTH AND FUEL POVERTY

FUNDING - Local Authorities Invited to Apply for Central Heating Fund

DECC is inviting local authorities, working with their local partners, to apply for a share of £25m capital funding to be used to improve the housing of those in fuel poverty living in their area. Local authorities are asked to come forward with developed proposals that meet the primary aim of the Central Heating Fund, to incentivise the installation of first time central heating systems in fuel poor households who do not use mains gas as their primary heating fuel.

Applications may be submitted up to 5th June 2015. Bids should be submitted electronically to: chf@decc.gsi.gov.uk

Fuel Poverty and Health Boost

Two North West local authorities have secured funds through the "Fuel Poverty and Health Booster Fund" from DECC. Blackburn with Darwen Borough Council working with Royal Blackburn Hospital have received £50,000 to support their hospital discharge scheme installing measures in combination with ECO funding where possible. Wigan Council have also received £100,000 to support their Affordable Warmth Access Referral Mechanism.

UKCIP Reports: Flurry of Activity in the House of Commons Before Recess:

A) MPs on Climate Change Adaptation

The Environmental Audit Committee of the House of Commons has published its report into adaptation to climate change in the UK. The Committee's main conclusions relate to flooding, particularly concern about the continued construction of homes on floodplains. The report also calls for a clear strategic lead on adaptation from central Government, including the appointment of an adaptation champion. Parliament UK: Climate change adaptation inquiry

B) MPs oOn Flood Defence Spending

The House of Commons Public Accounts Committee has published a report which raises concern about the sustainability of current levels of flood protection. The Committee praises the efforts of the Department for Environment, Food and Rural Affairs in improving cost effectiveness, but believes that decisions about prioritisation need to be more transparent.

Community Energy Strategy Update

DECC have published the first update to the UK Community Energy Strategy. Announcements include:

- Almost £1 million to develop a best practice local authority community energy programme
- £1.3 million for the Big Energy Saving Network
- · Commissioning of new research to build on our community energy evidence base
- Creation of a new Community Energy Efficiency Working Group
- Funding 17 Community Energy Savings Competition projects, above our original commitment of funding 5 projects
- Introducing a new innovation programme on solid wall insulation to help skill up community energy groups during the installation process

Speakers from pioneering projects from around the UK shared their experiences and a programme of workshop sessions helped build a practical understanding of how more communities can work together for local energy.

The event also explored key issues around where to find funding, empowering the local community and building partnerships that bring about real social impact including presentations from Pure Leapfrog, Pier 11 C.I.C, ResPublica and Carbon Co-op.

NEW SUDS TECHNICAL STANDARDS

Defra has launched the non-statutory technical standards for the design, maintenance and operation of SuDS to drain surface water

The standards apply to systems that drain surface water from housing, non-residential or mixed use developments for the lifetime of the developments.

Planning Update on Solar Permitted Development Rights

At the end of March the Government announced that it was relaxing the requirement to apply for planning permission for the installation of rooftop solar panels on non-domestic buildings. Previously, the threshold for permitted development rights was 50kW but from 6 April 2015 developments generating up to 1MW of electricity will now benefit from permitted development rights contained within the Town and Country Planning (General Permitted Development) (England) Order 2015.
